


# OUR COMMITMENT

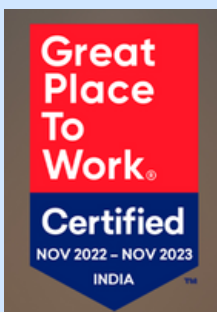
